Sir/Madam,

I write to inform you that University main examinations of will start 05.05.2022. You are aware that the State Government has taken a serious view regarding Unfair Means in University Examinations and has issued a notification dated 11.11.1992 related to Rajasthan Public Examination **Prevention of Un-fair means Act 1992 (copy enclosed)**. As per the provision of this Act an F.I.R. is to be lodged with the Police by the concerned Centre Superintendent.

You are requested to ensure compliance of this Act at your Examination Centre. All concerned including the staff and the examinees at the College may be well informed regarding the Act. **A copy of the same may also be displayed on the Notice Board.**

As per directions of state Government vide letter No. FG(CCE/NS/15/1728 dated 02-12-2015. It may kindly be ensured that CCTV Camera be installed before the commencement of the Examination 2022. It may kindly be also ensured that all the cameras should be functional round the clock without failure. The persons deputed by the University may check the recording if needed at any time.

**MOBILE PHONES ARE STRICTLY PROHIBITED IN THE EXAMINATION HALL.** Examinees may be announced that they should come for examination leaving their mobile phones outside the examination centre.

A set of different prescribed proformas is being sent herewith for your ready reference and for use at the time of forwarding un-fairmeans cases to the **Asstt. Registrar Exam.III (U.M.) University of Rajasthan, Jaipur.**

It has been observed in the past that while forwarding the Un-fairmeans cases to the University, no **Question Paper** is attached with the answer books. **Examinee's address** is also not mentioned completely in Form No. 39(E). As a result, assessment of answer books is delayed and difficulties experienced to inform the candidate.

**It is therefore, requested to ensure that:-**

1. Each Unfair means case carries with it relevant question paper.
2. Complete address of the examinee is clearly mentioned in Form No. 39(E).
3. Answer books of U.M. cases are not to be packed along with the answer books of other candidates.
4. The answer books (first and second both) of U.M. case are to be sealed in one envelope.
5. These sealed envelopes are to be addressed to the Asstt. Registrar Exam.III (U.M.) University of Rajasthan, Jaipur-302055.
6. "U.M. case(s)" must be mentioned on such sealed envelopes.
