## II. **Fee and Honorarium**

The activities will be timely evaluated to maintain the effective working of the MoU. This MOU had a funding that is provided by the; St. Xavier's College, Jaipur, for help in whatever ways possible. College is providing Rs 13000/- To JHW Just Health & Wellness for medicines which they will provide free of cost to the villager.

## III. **TERMS OF RENEWAL, AMENDMENT, AND TERMINATION**

This MOU shall remain in force for a period of 6 months from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months' notice to the other Party in writing. If this agreement is terminated by either party, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the parties agree in writing to renew it. This MOU may be amended by the exchange of official letters between the two parties. Such amendments, once approved by both Parties, will become part of this MOU.

Neither Party may assign this MOU or any right under this MOU without the prior written consent of the other Party. This MOU shall become effective upon the signature of the legal representatives from each party.

##### o NO TENANCY OR INTEREST IN PROPERTY

- Nothing in this MOU shall create or shall be construed to create any tenancy or to confer or be construed to confer upon one Party any interest in any, all or part of the grounds, building or premises of the other Party.

##### o NOTICES



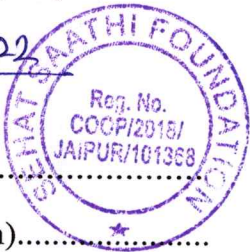
