## I. Knowledge and Facilitation Partner:

Connectscape has agreed to be the Knowledge & Facilitation Partner of 'SXC Jaipur'. This MOU will facilitate the Certificate Course in 'New Media & Journalism'.

Benefits of Collaboration: This collaboration for this course would equip the learner with in-depth knowledge of the skillset and scalability of Journalism. The insight to the latest reporting, writing, and technical skills for traditional and digital media, introduction to multimedia communication, identifying and pitching newsworthy stories, mastering the art of digital storytelling along with illustrated details and understanding the importance of graphics, fonts, digital marketing and management and digital strategy to become employable.

### II. Roles & Responsibilities:

#### Connectscape

- Conduct a Certificate Course in 'New Media & Journalism'
- The classes would be conducted online at a time mutually agreeable
- The course will be spanned across 30 hours or 30 classes
- The course shall be conducted online on Google Meet platform
- The course shall be conducted for a minimum of 20 (students) batch size
- Certificates would be graded based on assignments along with the class performance over the course duration

- A minimum batch of 20 students would be necessary to start the course
- To coordinate various managerial activities and interact with the 'SXC Jaipur' and 'Connectscape'
- Certificates would be graded based on assignments along with the class performance over the course duration

#### III. Fee and Honorarium

Fees payable to Connectscape by 'SXC Jaipur' will be as under:

- The fee of the course proposed is Rs. 2000 for students of St. Xavier's College, Jaipur & Rs. 3500 for students from other colleges and institutions for the course for each interested student.
- The remuneration will be on the 70:30 basis. The 70% of the revenue generated is to be paid by St. Xavier's College, Jaipur to Connectscape (50% before the commencement of the course and 50% after the completion of the course).
- Payment Terms: The fees as mentioned at III shall be done through NEFT or Cheque in the name of 'Jennifer Serene Consultancy' (parent company of Connectscape)

#### IV. Terms of Renewal, Amendment, And Termination

This MOU shall remain in force for a period of one year from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months' notice to the other Party in writing. If this agreement is terminated by either party, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the parties agree in writing to renew it. This MOU may be amended by the exchange of official letters between the two parties. Such amendments, once approved by both Parties, will become part of this MOU. Neither Party may assign this MOU or any right under this MOU without the prior written consent of the other Party. This MOU shall become effective upon signature of the legal representatives from each party

#### V. Other Terms and Conditions

• Compliance with Laws

Both parties will comply with all relevant laws in the jurisdiction in which it is in situated and all visiting scholars and faculty shall comply with all relevant laws in the jurisdiction of the host Party.

• Compliance with College Rules

Visiting party will comply with the rules of the host institution.
