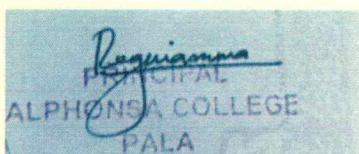

### **Background Alphonsa College, Pala**

- Alphonsa College, Pala, Kottayam District is one of the pioneer institutions for the higher education of women in the state of Kerala. It perpetuates the sacred memory of St. Alphonsa, the contemplative mystic whose saintly life of love and service has always been an inspiration and source of strength for the people around her.
- Established in 1964 as a Junior College with 400 students and 13 teachers, Alphonsa College has now attained the status of a First Grade Woman's College.
- The college is run by the Catholic Diocese of Pala. His Excellency Late Mar Sebastian Vayalil was the founder – patron of the institution. His Excellency mar Joseph Pallikkapparambil Emeritus Bishop of Pala was the patron of the college from 1981 to 2004.
- The institution at present is run under the efficient stewardship of His Excellency Mar Joseph Kallarangattu, Bishop of Pala – the present patron, His Excellency Mar Jacob Muricken–the Manager, and Rev. Dr. Sr. Regeenamma Joseph – the Principal, RevDr.Shaji john and Rev. Dr. Sr. Minimol Mathew – the Vice Principals and Rev. Dr. Jose Joseph – College Bursar. The college was declared as a Minority Educational Institution by the National Commission for Minority Educational Institution, Government of Kerala.

### **St. Xavier's College, Jaipur**

- The Jaipur Xavier Educational Association (J.X.E.A.) established in 1950, as a registered charitable society managed by the Jesuits, has been pursuing the legacy of St. Francis Xavier of promoting human fulfilment by means of training and education in India.
- In 2010, the J.X.E.A. in collaboration with the Xavier Alumni/ae and the well-wishers of Jaipur under the leadership of Rev. Fr. Varkey Perekatt, S.J., initiated a Higher Education Programme by establishing St. Xavier's College, Jaipur.

**I. Knowledge and Facilitation Partner**

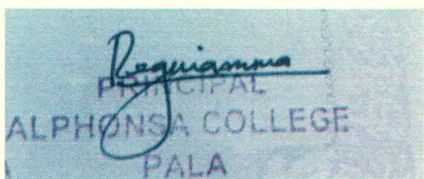

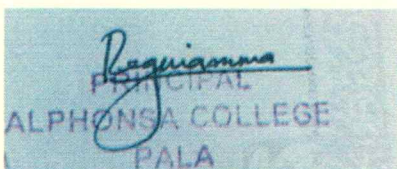
**III. Fee and Honorarium**

Honorarium will be decided on the basis of mutual understanding of both the parties, depending on the strength of students who will register for the course.

**IV. TERMS OF RENEWAL, AMENDMENT, AND TERMINATION**

This MOU shall remain in force for a period of one year from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months notice to the other Party in writing. If this agreement is terminated by either party, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the parties agree in writing to renew it. This MOU may be amended by the exchange of official letters between the two parties. Such amendments, once approved by both Parties, will become part of this MOU. Neither Party may assign this MOU or any right under this MOU without the prior written consent of the other Party. This MOU shall become effective upon signature of the legal representatives from each party

**V. OTHER TERMS AND CONDITIONS**

○ **COMPLIANCE WITH LAWS**

- Both parties will comply with all relevant laws in the jurisdiction and all visiting scholars and faculty shall comply with all relevant laws in the jurisdiction of the host Party.

○ **COMPLIANCE WITH COLLEGE RULES**

- Visiting party will comply with the rules of the host institution.

○ **NO AGENCY**

- Nothing in this MOU gives rise to a relationship of agency between the parties.

○ **NO JOINT VENTURE, PARTNERSHIP OR EMPLOYMENT RELATIONSHIP**

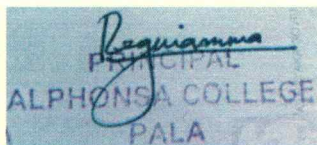
- Nothing in this MOU shall be relied upon to construe a joint venture, partnership or employment relationship between the Parties.

○ **NO TENANCY OR INTEREST IN PROPERTY**

- Nothing in this MOU shall create or shall be construed to create any tenancy or to confer or be construed to confer upon one Party any interest in any, all or part of the grounds, building or premises of the other Party.

○ **NOTICES**

- Any notice or other communication to any party hereto (whether required or permitted to be given under or in connection with this MOU) shall be in writing and shall (at the option of the party giving the notice) be sent by registered post to the address set out under its name below, or to such other address as is from time to time notified to the party giving the notice in compliance with the provisions of this clause IV
