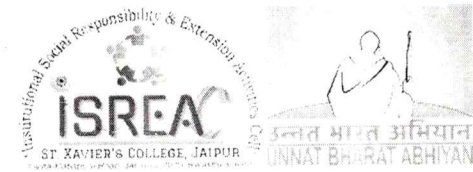

WHEREAS:

'SXC Jaipur' and the 'Naya Sawera', recognising the value of cooperation, have agreed to enter into this Memorandum of Understanding ('MOU') regarding academic/non-academic collaboration. 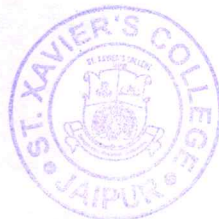
I. Roles & Responsibilities:

II. Fee and Honorarium

The activity will be evaluated to maintain the effective working of the MoU. This MoU is not a commitment of funds; St Xavier's College, Jaipur, will extend its help in whatever ways possible.

III. TERMS OF RENEWAL, AMENDMENT, AND TERMINATION

This MOU shall remain in force for a period of one year from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months' notice to the other Party in writing. If this agreement is terminated by either party, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the parties agree in writing to renew it. This MOU may be amended by the exchange of official letters between the two parties. Such amendments, once approved by both Parties, will become part of this MOU. Neither Party may assign this MOU or any right under this MOU without the prior written consent of the other Party. This MOU shall become effective upon signature of the legal representatives from each party

IV. OTHER TERMS AND CONDITIONS

○ COMPLIANCE WITH LAWS

- Both parties will comply with all relevant laws in the jurisdiction in which it is in situ and all visiting scholars and faculty shall comply with all relevant laws in the jurisdiction of the host Party.

○ COMPLIANCE WITH COLLEGE RULES

- Visiting party will comply with the rules of the host institution.

○ NO AGENCY

- Nothing in this MOU gives rise to a relationship of agency between the parties.

○ NO JOINT VENTURE, PARTNERSHIP OR EMPLOYMENT RELATIONSHIP

- Nothing in this MOU shall be relied upon to construe a joint venture, partnership or employment relationship between the Parties.


○ NO TENANCY OR INTEREST IN PROPERTY

- Nothing in this MOU shall create or shall be construed to create any tenancy or to confer or be construed to confer upon one Party any interest in any, all or part of the grounds, building or premises of the other Party.

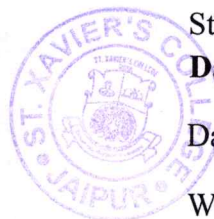
