

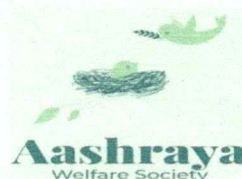
MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on 3rd day of September, 2022

BETWEEN St. Xavier's College, Jaipur having an address at Nevta-Mahapura Road, Nevta, Jaipur, Rajasthan – 302029 (hereinafter referred to as SXC') AND Aashraya Welfare Society NonGovernmental organization, having an address at 9, Shankar Colony, Sawai Gate, Jagtapura, Jaipur (hereinafter referred to as 'Aashray Welfare Society' and collectively referred to as 'the Parties')

WHEREAS:

'SXC Jaipur' and Aashray welfare Society, recognizing the value of cooperation, have agreed to enter into this Memorandum of Understanding ('MOU') regarding academic/non-academic collaboration. The purpose of this non-binding Memorandum of Understanding (MOU) is to make possible and to institute academic collaboration/ strategic partnership between 'St Xavier's College, Jaipur', and 'NGO Aashray Welfare Society', based upon the principles of mutual equality and the reciprocity of benefits.

Background

- Aashraya Welfare Society was found in 2009. It started with our Founder and Director, Ms Anna Wogg. After going through tumultuous circumstances, took a decision to not let another voice get silenced. She started by visiting slums and teaching illiterate women. Soon she felt that their needs were not limited to learning to read and write but were multifaceted.
- It marked the birth of an organization that would in future help countless people and bring smiles to their faces. Aashraya is a social, charitable, non-profit organization which works for the upliftment of the helpless to a better standard of life.
- Aashraya works for those who are fettered to the bondages of poverty and despair, giving them wings to fly. It succors and supports women, children and people from all milieus who are unable to help themselves. It reinforces this vision through projects and programs like Adult Literacy, Education Sponsorships, and Vocal Trainings, distributing rations, clothing the unclothed and fighting against injustices that prevail through social evils in our society.

St. Xavier's College, Jaipur

- The Jaipur Xavier Educational Association (J.X.E.A.) established in 1950, as a registered charitable society managed by the Jesuits, has been pursuing the legacy of St. Francis Xavier of promoting human fulfilment by means of training and education in India.
- In 2010, the J.X.E.A. in collaboration with the Xavier Alumni/ae and the well-wishers of Jaipur under the leadership of Rev. Fr. VarkeyPerekkatt, S.J., initiated a Higher Education Programme by establishing St. Xavier's College, Jaipur. Since then, the college has grown manifold directions, serving the educational needs, not only of the people of Jaipur but also across the nation. Over the last 10 years we have grown from a sapling to a huge oak, and every year the college has marked new milestones.
- In 2021, St. Xavier's College, Jaipur shifted to Nevta campus with the merging of St. Xavier's College, Nevta into SXC, Jaipur. This was a big step in the direction of imparting quality education with world class infrastructure.

Both Parties HEREBY AGREE:

I. Knowledge and Facilitation Partner

SXC Jaipur has requested Ashraya Welfare Society Jaipur, Non-Governmental organization to be its partner in the philanthropic outreach programs in villages with Department of Political Science, St Xavier's College-Jaipur. Ashraya Welfare Society, Jaipur has agreed to be a facilitation Partner of St. Xavier's College Jaipur.

This MOU will facilitate the outreach programs to provide students with outcome based learning. Both sides will contribute to foster and develop a sense of responsibility to the students towards the vulnerable and down trodden of the society and develop a cooperative relationship between the two organizations for a constructive outcome.

II. Roles & Responsibilities:

St. Xavier's College, Jaipur

- Exchange of youth for philanthropic activities.
- Providing food and Nutrition to the poor.
- Conducting counselling camps for the villagers
- Teaching slum children.

Aashraya Welfare Society, Jaipur

- Organizing events for the villagers.
- Conducting Camps for adult and Children
- Organize a Digital-Literacy Program
- Training Women in Skill development for Employment.
- Providing social service in slum areas

III. Fee and Honorarium

Honorarium will be decided on the basis of mutual understanding of both the parties, depending on the strength of students who will register for the course.

IV. TERMS OF RENEWAL, AMENDMENT, AND TERMINATION

This MOU shall remain in force for a period of one year from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months' notice to the other Party in writing. If this agreement is terminated by either party, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the parties agree in writing to renew it. This MOU may be amended by the exchange of official letters between the two parties. Such amendments, once approved by both Parties, will become part of this MOU. Neither Party may assign this MOU or any right under this MOU without the prior written consent of the other Party. This MOU shall become effective upon signature of the legal representatives from each party

V. OTHER TERMS AND CONDITIONS

- **COMPLIANCE WITH LAWS**
 - Both parties will comply with all relevant laws in the jurisdiction in which it is in situ and all visiting scholars and faculty shall comply with all relevant laws in the jurisdiction of the host Party.
- **COMPLIANCE WITH COLLEGE RULES**
 - Visiting party will comply with the rules of the host institution.
- **NO AGENCY**
 - Nothing in this MOU gives rise to a relationship of agency between the parties.
- **NO JOINT VENTURE, PARTNERSHIP OR EMPLOYMENT RELATIONSHIP**
 - Nothing in this MOU shall be relied upon to construe a joint venture, partnership or employment relationship between the Parties.
- **NO TENANCY OR INTEREST IN PROPERTY**
 - Nothing in this MOU shall create or shall be construed to create any tenancy or to confer or be construed to confer upon one Party any interest in any, all or part of the grounds, building or premises of the other Party.
- **NOTICES**
 - Any notice or other communication to any party hereto (whether required or permitted to be given under or in connection with this MOU) shall be in writing and shall (at the option of the party giving the notice) be sent by registered post to the address set out under its name below, or to such other address as is from time to time notified to the party giving the notice in compliance with the provisions of this clause IV:


- The terms of this MOU represent the current intentions of the Parties as at the time of signing. With the exception of Clause -V, this MOU is not legally binding on the parties.
