



MEMORANDUM of UNDERSTANDING

This Memorandum of Understanding is made on the 29th day of April 2022

BETWEEN St. Xavier's College, Jaipur (hereinafter referred to as 'SXC Jaipur') having an address at Nevta- Mahapura Road, Nevta, Jaipur, Rajasthan – 302029 **AND** DICAST Education Pvt. Ltd., having an address at D-56, 80-Feet Road, Mahesh Nagar, Jaipur. (hereinafter referred to as 'DICAST' and collectively referred to as 'the Parties')

WHEREAS:

'SXC Jaipur' and the 'DICAST', recognizing the value of cooperation, have agreed to enter into this Memorandum of Understanding ('MOU') regarding academic/non-academic collaboration. The purpose of this non-binding Memorandum of Understanding (MOU) is to make possible and to institute academic collaboration/ strategic partnership between 'SXC Jaipur', and 'DICAST', based upon the principles of mutual equality and the reciprocity of benefits.

- **Ensure Certification after online Exam**



III. Fee and Honorarium (Mention if required)

Fees payable to DICEST Education Pvt. Ltd by SXC Jaipur will be as under:

- Online Mode 700 Rs / Day
- Offline Mode 1300 Rs/ Day



Payment Terms: Half in Advance and Remaining Half after completion course.

III. TERMS OF RENEWAL, AMENDMENT, AND TERMINATION

This MOU shall remain in force for a period of (1) years from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months' notice to the other Party in writing. If this agreement is terminated by either party, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the parties agree in writing to renew it. This MOU may be amended by the exchange of official letters between the two parties. Such amendments, once approved by both Parties, will become part of this MOU. Neither Party may assign this MOU or any right under this MOU without the prior written consent of the other Party. This MOU shall become effective upon signature of the legal representatives from each party

IV. OTHER TERMS AND CONDITIONS

○ COMPLIANCE WITH LAWS

- Both parties will comply with all relevant laws in the jurisdiction in which it is in situ and all visiting scholars and faculty shall comply with all relevant laws in the jurisdiction of the host Party.

○ COMPLIANCE WITH COLLEGE RULES

- Visiting party will comply with the rules of the host institution.

○ NO AGENCY

- Nothing in this MOU gives rise to a relationship of agency between the parties.

○ NO JOINT VENTURE, PARTNERSHIP OR EMPLOYMENT RELATIONSHIP

- Nothing in this MOU shall be relied upon to construe a joint venture, partnership or employment relationship between the Parties.

○ NO TENANCY OR INTEREST IN PROPERTY

- Nothing in this MOU shall create or shall be construed to create any tenancy or to confer or be construed to confer upon one Party any interest in any, all or part of the grounds, building or premises of the other Party.

○ NOTICES

- Any notice or other communication to any party hereto (whether required or permitted to be given under or in connection with this MOU) shall be in writing and shall (at the option of the party giving the notice) be sent by registered post to the address set out under its name below, or to such other address as is from time to time notified to the party giving the notice in compliance with the provisions of this clause IV:
