4. Details of the Activities Organized/ Work Performed:

The IQAC has been diligently progressing with its quality initiatives and preparations for NAAC accreditation, which were initiated during the academic session of 2018-19. Our objective for this year was to embark on the first cycle of accreditation by the session's end.





In June 2022, the management approved the timeline for executing the tasks associated with NAAC preparation. The following initiatives were taken during the academic session 2022-23:

- a. In July 2022 IQAC conducted a series of meetings with the NAAC steering committee, heads of the departments, and staff members to prepare the roadmap for the accreditation process.
- b. The IQAC serves as a vital bridge between the UGC and various units within the college, facilitating the implementation of the Quality Mandate outlined by the UGC. As part of the endeavour to enhance the quality of education in Higher Education Institutions (HEIs), the UGC developed an 11-point program. Keeping this in mind, the IQAC has continued its Academic Planning efforts by systematically collecting event proposals from all college units for the 2022-23 session. These proposals were consolidated into the college's Academic Planner through extensive consultation with all departments and major units.
- c. A Capacity Building Workshop on Understanding Research and Best Practices for Institutional Development was successfully conducted at the college in collaboration with Banasthali Vidyapith from 25th to 29th July 2022. The primary aim of the workshop was to provide faculty members with valuable insights into enhancing their research productivity, effectively managing human resources and developing a comprehensive understanding of best practices for the institution. Additionally, the non-teaching staff received training in soft skills, and technical skills, and gained a comprehensive understanding of best practices for the institution. Esteemed resource persons, including Prof. Harsh Purohit, Dean, Faculty of Management Studies at Banasthali Vidyapith, Dr. Prakash Chand, Head of the Indian Citation Index, Fr. Nelson D'Silva, Vice-President, JXEA, Dr. Ranjit Kaur, Assistant Professor, Department of English, St. Xavier's College, Jaipur, and Dr. Vaishali Singh, Assistant Professor, Department of Computer Science, St. Xavier's College, Jaipur, delivered valuable sessions during the workshop.
- d. A Seven-day Student Induction Programme Deeksharambh was organized by the IQAC from 13-20 Sept to orient the freshers about the college units and department activities and facilities as a part of mandatory guidelines of UGC.

- e. To ensure thorough preparation for the first cycle of NAAC Accreditation, the IQAC scheduled an expert visit for both teaching and non-teaching staff from 28th November to 9th December. The primary objective of this visit was to assess the readiness of various units concerning all seven criteria of assessment and accreditation. During the visit, Fr. Dr. Lawrence Amalraj SJ from Loyola College, Chennai, and Sr. Dr. Candy D'Cunha, the NAAC Coordinator at Andhra Loyola Institute of Engineering and Technology, Vijayawada, served as resource persons. They conducted a comprehensive assessment of the college's preparedness for NAAC, diligently examining each criterion. Following the visit, the experts compiled a detailed report outlining their assessment findings. This report, along with additional inputs from the IQAC, was subsequently submitted to the college management for further consideration and action.
- f. Feedback on teaching-learning (Annual Academic Feedback for the teaching staff) with the help of ERP for all staff was conducted in January 2023. The report on the same along with feedback results was submitted to the principal.
- g. IQAC has prepared an Action Plan for the College and its various units based on the recommendations of external experts, suggestions from departments, and steering committee. The criteria-wise Action Plan keeping in mind the NAAC accreditation is submitted to the college management for necessary approval and implementation from the next session.
- h. NIRF 2022 data was collected and submitted for the ranking process with the help of the university affairs cell and college office.
- Documentation Centre collected the event information data in a structured manner throughout the year from different units of the college for session 2022-23.
- j. Performance Based Appraisal System (PBAS) has been developed by IQAC based on the API format of UGC. It will be circulated amongst all teaching staff members for self-evaluation for the session 2022-23.


