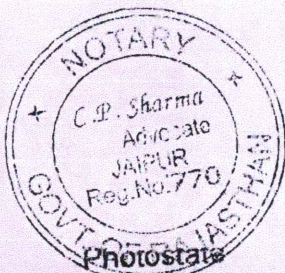

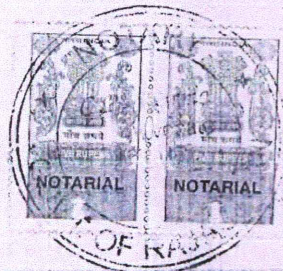

MEMORANDUM OF ASSOCIATION

OF THE

JAIPUR XAVIER EDUCATIONAL ASSOCIATION

1. **Name:** The name of the association is: The Jaipur Xavier Educational Association (hereinafter called the "Association").

2. **Registered Address:** The registered Address of the association is: St. Xavier's high school, Jaipur City, Rajasthan, India.

3. **Objects:** The objects for which the Association is established are the following and it is declared that the several sub-clauses of this clause and all the powers mentioned in it are to be cumulative and in no case is the generality of the sub-clause to be narrowed or restricted by any particularity of any other sub-clause nor will any general expression in the same sub-clause nor will any general expression in the same sub clause or the application of any rule of construction "ejusdem generis" or otherwise:-

- (a) To perform the works of charity- Social, Moral, Corporal, and Spiritual;
- (b) To diffuse Social, Religious and Secular Knowledge.
- (c) To establish, conduct, maintain, manage, run, equip, close down or dispose of schools, vocational technical institutes, hostels and other educational centres;
- (d) To give awards, scholarship for educational faculties to deserving students, trainees and to help the needy and deserving students by way of providing them school uniforms, books and loans to pursue education.
- (e) To give aid, grants, support to schools, educational institutions, vocational centers and others for carrying out the activities for the benefit of public in general .
- (f) For the purpose aforesaid or in furtherance thereof:

- (i) To acquire by purchase, lease gift, legacy, and bequest or otherwise from any person, company or institution whatsoever and to hold all or any part of the movable or immovable properties of all descriptions now or hereafter vested in or in the possession of the Rector, for the time being, of the Saint. Xavier's High School situated in the City of Jaipur, State of Rajasthan or now or hereafter vested in or in possession of any other person or body or used or devoted for or to any purpose of the said high school or any Charitable, Educational, Cultural, Social, Moral, Religious, Scientific or other purpose whatsoever in connection therewith and to have the name /names of any or all of the above-mentioned mutation in any Court or Office whatsoever (Civil, Criminal, Revenue, Municipal, Estate etc.) to that of the said association:

- (ii) To maintain, deal with and manage the said movable and immovable properties of all descriptions of the said Association:
- (iii) To alienate by way of sale, mortgage, lease, exchange, hiring out, gift or otherwise any or all the properties of the association or portions thereof;
- (iv) To erect School Buildings, Dormitories, Hostels, Orphanages, Bungalows, Chapels, Stadium and any other type of building or construction whatsoever to further the purposes of the said Association and to maintain, alter, demolish or reconstruct the same or any portion or portions thereof;
- (v) To invest or deal with the moneys of the Association not immediately required upon securities or in such manner as from time to time may be determined by the governing body of the association.
- (vi) To take or receive any gift, whether money or property, movable or immovable, such as Real Estate, Stocks, Bonds etc. whether by gift of the person living or by legacy, bequest etc. for any of the objects of the association and moreover to take such steps for the securing of such contributions to the funds of the associations as may be deemed expedient;
- (vii) To enter into arrangements with any Government or Authority, whether Supreme, State, Provincial, District, Municipal, Local or otherwise that may seem to be conducive to the objects of the Association or any of them and to obtain from any Government or Authority such rights concessions, and privilege as the Association may think desirable and to obtain, carry out, exercise and comply with any such arrangements, rights, privileges, and concessions;
- (viii) To borrow and raise funds, with security or without security, in any manner the Association may think fit and to repay the same;
- (ix) To hire and employ Professors, School Masters, Tutors, Teachers, Specialists, Scientists, and Managers, Secretaries, Clerks, Accountants, Servants, and Workmen and others and to pay them salaries, wages, gratuities, and pensions;
- (x) To do or cause to be done all such other things as are in accordance with the Spirit and the Principles of the constitution of the Society of Jesus which are incidental or conducive to the Social, Moral, Cultural, Religious, Patriotic, Civic, and Physical Welfare of the inhabitants of the Province of Rajasthan in particular and the people of India as a whole;
- (xi) The income, property and/or corpus of the society whensoever derived shall be applied solely towards the promoting of the

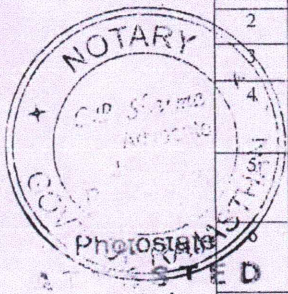
objects of the society as set forth in the Memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly by way of dividend or bonus or otherwise howsoever, by way of profit to the persons who at any time are or have been members of the society or to any person claiming through any of them. Provided that nothing herein contained shall prevent the payment in good faith of remuneration to any officers or servants of the society or to any member thereof or other person in return for any service actually rendered to the society.

4. Governing Body: The Names, Offices, Occupations and Addresses of the Officers of the Governing body to whom by the Rules and Regulations of the Association the Management of its affairs are entrusted, i.e. the President, the Treasurer and the Secretary are set out hereunder, namely:-

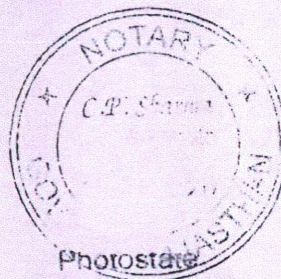

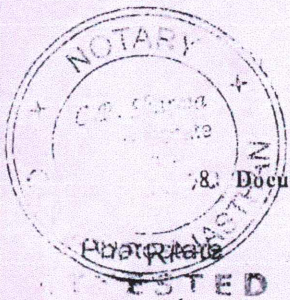

**RULES AND REGULATIONS
OF THE
JAIPUR XAVIER EDUCATIONAL ASSOCIATION**

(In accordance with the Societies Registration Act XXI of 1860)

1. **Name:** The name of the society is: Jaipur Xavier Educational Association, (hereinafter called the "Association").
2. **Objects:** The objects for which the society is established are stated in paragraph number three of the Memorandum of Association.
3. **Members:** Only members of the Society of Jesus (as established and recognized by the Roman Catholic Church) are eligible as members of the Association.
4. **Fees:** No subscription, fees or contributions are paid by the members.
5. **Membership:** The number of members of the Association, including the members of the governing body, shall not be less than seven, nor more than thirty. The members of the Association, other than "ex-officio" members shall be appointed, and may be retired, suspended or expelled by the President. The proof of the membership, for other than "ex-officio" members, shall consist of member's signature in the membership roll along with the counter initials of the President or Vice-President. The proof of member's retirement, suspension or expulsion shall consist in a note to that effect entered in the "Remarks" column of the Membership Roll opposite the member's name, and counter-initialed by the President or Vice-President.
6. **Property:** All properties shall stand in the name of the Association.
7. **Vesting:**
 - (a) All immovable properties of the Association shall vest in the President, and the Vice President, for the time being of the Association.
 - (b) All, or any, movable properties of the Association shall vest in either the President, or the Vice-President, or the Treasurer, for the time being, of the Association.
8. **Documents:**
 - (a) All documents relating to or affecting the immovable properties or the rights and/ or privileges of the Association, shall be executed for and on behalf of the Association of the President, and the Vice-President, for the time being, of the Association, or by their duly appointed agents or agent.
 - (b) All documents relating to or affecting the movable properties of the Association shall be executed for and on behalf of the Association by either the President/ Vice-President or the Treasurer, for the time being, of the Association.

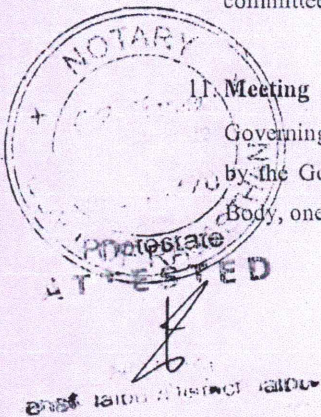
9. Members of the Governing Body:

- (a) The Governing Body of the Association shall consist of six members:-
- (i) The President (See No. 12 below);
 - (ii) The Vice-President (See No. 13 below);
 - (iii) Four other members, who shall be those four members of the Society of Jesus, who have been duly appointed as the Consulters of St. Xavier School, Jaipur.
- (b) These six members of the Governing Body shall be the only "ex-officio" members of the Association. They shall be bonafide members of the Association as soon as they shall have been appointed to those positions which carry with them "ex-officio" membership, even if they have not yet signed the Membership Roll. Should a vacancy occur in one or more positions in the Governing Body because of vacancies, for the time being, in those positions in the St. Xavier School, Jaipur, which carry with them "Ex-Officio" positions in the Governing Body, all acts and deeds of the reduced Governing Body shall be as valid and effectual as if every such "ex-officio" positions were filled and the Governing Body consisted of the regular number of six members.
- (c) The members of the Governing Body as such shall receive no reward or remuneration.

10. **Powers of Governing Body:** Subject to the Rules and Regulations of the Association, and without prejudice to any power given to any individual officer of the Association by said rules, the Governing Body of the Association shall have the full power of the Association; that is, the Governing Body shall be authorized, and is hereby empowered to do all those acts and things for which the Association have been formed and which are listed in paragraph number three of the Memorandum of Association. The Governing Body may exercise its powers either directly, or through its duly appointed delegates, committees, agents or agent.

11. **Meeting of the Governing Body:** The quorum necessary for the meeting of the Governing Body and for the transaction of the business of the Association may be fixed by the Governing Body, and unless so fixed, shall be two members of the Governing Body, one of whom shall be the President or the Vice President, PROVIDED that:

- (a) When only two members form a quorum they must act jointly, i.e. questions shall be decided by unanimous vote: when more than two are present at a meeting, questions shall be decided by a majority vote.
- (b) Any meeting at which it is proposed to vote on a resolution involving the sale of property or the expenditure of funds exceeding the value of Rs

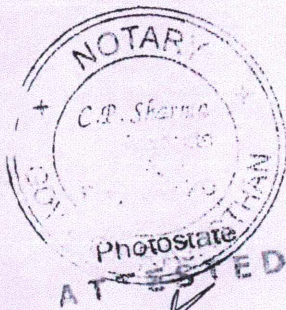

500000/- (Rupees Five Lakhs only) must be held under the chairmanship of the president, or his duly appointed proxy, and no such resolution can be validly passed unless the president shall have voted in favour of it.

- (c) Any meeting at which it is proposed to vote on a resolution involving the sale of property, or the expenditure of funds exceeding the value of Rs 1500000/- (Rupees Fifteen Lakhs only) or at which it is proposed to alter the Rules, requires the presence of all members of the governing body, either in person or by proxy, and no such resolution can be validly passed unless the President shall have voted in favour of it.

12. President: The President of the Association shall be that member of the Society of Jesus, who, according to the constitutions and laws of the said Society of Jesus, is the duly appointed Provincial, Vice Provincial, or Acting Head of that religious territory or Province of the Society of Jesus in which the registered address of the Association is situated. The President shall have the overall direction and supervision of the works of the Association, and in particular shall be empowered and is hereby authorized to do among others, the following:-

- (a) To appoint, transfer, and/or retire the religious personnel of the staff working under the Governing Body of the Association, and from among them to determine who shall be Heads of departments, such as Principal, Superintendent of Buildings etc.
- (b) To authorize the acquisition or alienation of the property, whether movable or immovable, the purchase or sale of equipments and furnishings, and the expenditure or disposition of funds of the Association up to the value of Rs 500000/- (Rupees Five Lakhs only) without calling a meeting of, or consulting the Governing Body.
- (c) To summon and preside as chairman of, meetings of the Governing Body, or of the General Body of the Association.

13. Vice President: The Vice-President shall be that member of the Society of Jesus who, according to the constitution and laws of the said Society of Jesus, shall have been duly appointed as the Rector or Local Heads of St. Xavier School, Jaipur. The Vice-President shall have the immediate control and supervision of all the institution working under the Association. In particular, he shall be empowered and is hereby authorized to do, among other things, the following:

- (a) To appoint, transfer, retire, suspend, and/or dismiss the lay members of the staffs working under the Governing Body of the Association, and to delegate this power to Heads of Departments with reference to the staff of their respective departments.

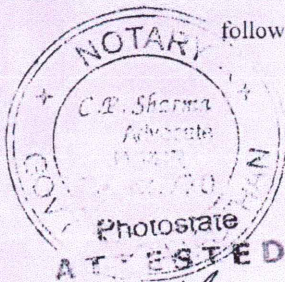
- (b) To incur, or authorize routine expenses in the running of the institutions working under the Governing Body or the purchase/ or sale of extraordinary equipments or furnishings up to the value of Rs Seven Thousand Five Hundred (Rs 7500.00) without calling a meeting of, or consulting the Governing Body.
- (c) To designate those who may pass bills in various departments of the institution working under the Governing Body;
- (d) To summon and preside as Chairman of meetings of Governing Body, or of the General Body of the Association, in the absence of the President.

14. **The Treasurer:** The President of the Association shall appoint a treasurer who shall be empowered and is hereby authorized to do, among other things the following:-

- (a) To maintain the account books of the Association,
- (b) To operate on the bank accounts of the Association,
- (c) To pass bills for payment in any department of the institutions working under the Governing Body,
- (d) To make payment by cash or cheque of any bills passed by the President, the Vice President or Heads of department or himself,
- (e) To issue petty cash for travel and other miscellaneous expenses of the Association to duly appointed members of the staff working under the Governing Body,
- (f) To receive payments due to the Association and to give receipts for the same,
- (g) To invest the funds of the Association not immediately needed for the works of the Association.


15. **The Secretary:** The Vice-President shall appoint a Secretary who shall handle all the official correspondence of the Association, and among other things shall do the following:-

- (a) Within fourteen days of the day on which the Annual General Meeting is held send to the Registrar a copy of the current list of the members of the Governing Body and a copy of the Rules and Regulations corrected up to date and certified to be a correct copy by not less than three members of the Governing Body,
- (b) Within fifteen days of any alteration made in the Rules and regulations of the Association forward a copy of the alteration to the Registrar, which copy shall be certified to be a correct copy by not less than three members of the Governing Body,

(c) Within fifteen days of any change in the members of the Governing Body inform the registrar of the same.

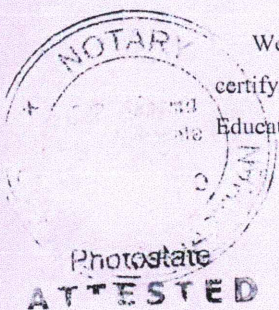
16. **Law Suits:** The association may sue or be sued in the name of the Vice-President or the Secretary.
17. **Annual General Meeting:** A General Meeting of the Association shall be held once a year before the 31st Day of March, under the chairmanship of the President or the Vice-President, to receive the financial report, to review the progress of works in hand and to plan future projects. The quorum for the Annual General Meeting shall be those members of the Association present at the registered address of the Association on the date set for the meeting.
18. **Extraordinary General meeting:** An Extraordinary General meeting of the Association to consider altering the purposes of the Association changing the name of the Association, the amalgamation, division or dissolution of the Association, shall be summoned and held according to the norms laid down in "The Rajasthan Societies Registration Act 1958".
- 18A. **Dissolution:** In case if necessary the society can be dissolved as per section 13 and of the Rajasthan Societies Registrar Act, 1958.
19. **Interpretation:** If any doubt arises as to the meaning of any rule, section, or phrase thereof, the President and Vice President shall give the interpretation of the same, which interpretation shall have the force and effect of a rule, unless and until it be otherwise determined at a General Meeting of the Association.
