1. Introduction

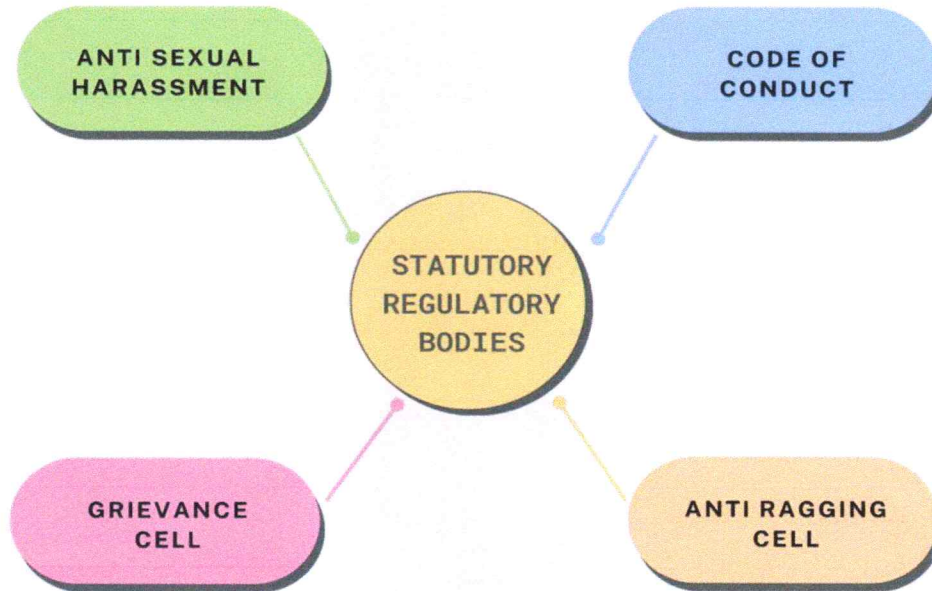
Statutory bodies are organizations or institutions that have been established by an act of parliament with regard to the Supreme Court Judgment and guidelines issued in 1997 to provide effective enforcement of the basic human rights of gender equality and guarantee against sexual harassment and abuse, more particularly against sexual harassment at work places, the University Grants Commission (UGC) has issued circulars since 1998, to all the educational institutions, advising them to establish a permanent cell and committee; to develop guidelines to combat sexual harassment, violence against women, ragging.

Keeping above guidelines in view St. Xavier's College Jaipur has constituted statutory/regulatory bodies for Anti ragging committee, grievance cell, anti-sexual harassment, and code of conduct. They play important roles in guiding academic programs, setting policies, managing administration, and overseeing finances of universities.

St. Xavier's College Jaipur has committed itself in creating a friendly and supportive atmosphere where students, teachers, and non-teaching staff can collaborate harmoniously. Their commitment is to ensure an environment that is free from violence, harassment, exploitation, and intimidation. Every individual within the college community is expected to understand and uphold the commitment to the rights of freedom of expression and association. The college strongly advocates for gender equality and firmly opposes any form of gender discrimination or violence.

2. Anti-Ragging Cell

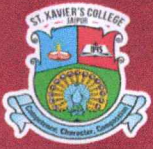
The college has taken strong measures to comply with the directives of the Supreme Court in order to prohibit, prevent, and eliminate ragging. Adequate publicity regarding this issue has been carried out through various mediums. It is important to note that ragging is considered a criminal offense according to the verdict of the Supreme Court and is also an offense under Penal Code.

Therefore, any behavior by students, whether through spoken or written words or through actions that involves teasing, treating, or handling fresher's or other students with rudeness, is considered as ragging. In addition, the institution is keen to observe any undisciplined or rowdy activities by any student or students which causes or likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.

The institution has a strict policy against all forms of ragging, which applies to all its departments, constituent units, and premises including academic buildings, residences, sports facilities, and cafeteria within the campus. Those found guilty of ragging or aiding in ragging will face severe consequences such as criminal charges and/or cancellation of admission. It is important to note that the responsibility lies with the perpetrator and not the victim. A complaint can be filed by the affected party or based on independent findings by the Anti-ragging Squad.

3. Code of Conduct Committee

The Code of Conduct committee at St. Xavier's college, Jaipur is constituted for the smooth implementation of the Code of conduct and ethics policy.

The committee frames a standard ethical and disciplinary code of conduct for all its employees/collaborators/stakeholders/students to help them know what is expected of them by the way of behavior as members/collaborators of/with the Xavier's family. It investigates and resolves any violations which are reported or suspected by the committee or others within the organization.

4. Anti-Sexual Harassment Cell

The Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redressal) Act in India was enacted in 2013 to provide protection and redressal for women who experience sexual harassment in the workplace. The act has three main purposes:

- **Prevention:** The act aims to create a safe and conducive work environment for women by mandating employers to take proactive measures to prevent sexual harassment.
- **Prohibition:** The act clearly defines what constitutes sexual harassment at the workplace and prohibits any form of unwelcome behavior, whether physical, verbal, or non-verbal, that creates a hostile or offensive work environment for women.
- **Redressal:** The act provides a mechanism for women to seek redressal for incidents of sexual harassment at the workplace.

The Act recognizes that sexual harassment of women results in violation of fundamental rights granted to women under the Indian Constitution.


In pursuance of the sexual harassment of women (Prevention, Prohibition, Redressal) the Institution established a separate cell under the Internal Complaints Committee (ICC) to take necessary and immediate action.

The committee conducts enquiry through forming an Internal Complaints Committee (ICC), at the time of any complaint, in order to suggest suitable action, as per the legal format of Vishakha Guidelines, Sexual Harassment at the Workplace Act 2013 and GOI's instructions concerning the same.

5. Grievance Redressal Cell

The grievance cell at St. Xavier's college, Jaipur attempts to address genuine problems and complaints of students whatever be the nature of the problem. The Grievance Cell has been formed solely to provide solutions for the grievances of the students which arise then and there.

This Cell is to maintain a fair, unbiased and consistent system for redressal of various issues faced by the students. To ensure strict confidentiality so that students approach the grievance Redressal Cell without the fear of any vindictive activity. The cell convenes periodic meetings and takes steps to redress the grievance.
