Preamble

This Memorandum of Understanding (MoU) is entered into on 3rd November 2023, between Inspirar Sports Private Limited and St. Xavier's College Jaipur Training Internship and Placement Cell (TIPC) & Department of Sports, with the aim of establishing a collaborative partnership for the mutual benefit of both parties. The purpose of this MoU is to provide internship opportunities and potentially facilitate placement for the students of St. Xavier's College Jaipur with a preference for candidates having a background in sports and maintaining a balanced academic performance.

1. Objectives:

11. **Internship Opportunities:** Inspirar Sports shall offer internship opportunities to eligible students of St. Xavier's College Jaipur in various domains relevant to the sports industry.
12. **Placement Assistance:** Inspirar Sports will explore the possibility of providing job placement assistance to students who have successfully completed their internships and met the required performance criteria.

2. Eligibility Criteria:

21. Internship and placement opportunities shall be primarily extended to students of St. Xavier's College who have demonstrated overall proficiency and have a keen interest in sports and sporting activities. This can include students from streams such as Management, Literature, Media as well as Commerce and Arts.
22. Applicants must also maintain a balanced academic performance, as defined by the academic guidelines of St. Xavier's College Jaipur.

3. Duration and Number of Internships:

31. The duration of the internship, including the start and end dates, will be determined on a case-by-case basis, subject to mutual agreement between Inspirar Sports and St. Xavier's College Jaipur with a minimum duration of one month.
32. The number of internships available in a given academic year will be decided jointly by both parties and communicated in advance.

4. Job description for Internship

Inspirar Sports will provide the job description & internship learning outcomes (ILO) for the internship one month in advance to the Training, Internship and Placement Cell (TIPC) of St. Xavier's College Jaipur.

5. Responsibilities of St. Xavier's College Jaipur:

51. St. Xavier's College Jaipur shall identify and recommend eligible students for internship opportunities at Inspirar Sports based on the specified criteria.
52. St. Xavier's College Jaipur will facilitate the necessary documentation and approvals required for students to participate in the internship program.

6. Responsibilities of Inspirar Sports:

61. Inspirar Sports will provide the necessary training, guidance, and supervision to interns during their tenure at the company.

6.2 Inspirar Sports shall pay the basic stipend of INR 5000 per month for students undergoing internships under this program. A student must be available to travel for at least 3 days a week each month to be eligible for the stipend.

6.3 Inspirar Sports shall evaluate the performance of interns and, subject to suitability, pay an extra incentive on top of the stipend. The evaluation shall be done in line with Inspirar Sports' performance evaluation matrix.

7. Non-Discrimination:

Both parties agree not to discriminate against any intern or applicant on the basis of race, colour, religion, gender, national origin, age, disability, or any other legally protected status.

8. Exiting the MoU:

Either party may exit the MoU with prior written notice of 15 days.

9. Confidentiality:

Both parties agree to maintain the confidentiality of any sensitive information shared during the collaboration.

10. Amendments:

Any amendments or modifications to this MoU shall be made in writing and agreed upon by both parties.

11. Signatures:

This MoU is executed in duplicate, with each party retaining one copy.
