# MEMORANDUM of UNDERSTANGING Between ST. XAVIER'S COLLEGE JAIPUR & SUMAN BLOOD BANK



This Memorandum of Understanding is made on the 27<sup>th</sup> day of September 2023 between NSS, St. Xavier's College Jaipur (herein referred to as 'SXC Jaipur') and having address at Nevta-Mahapura Road, Nevta, Jaipur, Rajasthan – 302029 and Suman Blood Bank having address at SFS 4/214, Shipra Path, 2 Bypass, Near B, RIICO Industrial Area, Mansarovar, Jaipur, Rajasthan 302020 (herein referred to as 'Suman Blood Bank' and collectively referred to as 'the parties').

SXC Jaipur and Suman Blood Bank, recognising the value of cooperation, have agreed to enter this Memorandum of Understanding (MOU) regarding academic/non-academic collaboration. The purpose of this non-binding Memorandum of Understanding (MOU) is to make possible and to institute welfare/strategic partnership between SXC Jaipur and Suman Blood Bank based upon the principles of mutual equality and reciprocity of benefits. This social activity is organized by the National Service Scheme Unit of St. Xavier's College Jaipur.

# **Background**

## **Suman Blood Bank**

Suman Blood Bank in Mansarovar, Jaipur, has been operating since the year 2017, and it is currently regarded as one of the most successful businesses in the area of Blood on Call Services in Jaipur. This well-known Blood Bank serves as a one-stop destination for people coming from across Jaipur, including those who live within the city. This company, over the course of its history, has worked tirelessly to solidify its position as a leader in the sector in which it operates.

### St. Xavier's College, Jaipur

The Jaipur Xavier Educational Association (J.X.E.A.) established in 1950, as a registered charitable society managed by the Jesuits, has been pursuing the legacy of St. Francis Xavier of promoting human fulfilment by means of training and education in India.

In 2010, the J.X.E.A. in collaboration with the Xavier Alumni/ae and the well-wishers of Jaipur under the leadership of Rev. Fr. Varkey Perekkatt, S.J., initiated a Higher Education Programme by establishing St. Xavier's College, Jaipur. # **Both Parties Hereby Agree:**

## 1. Roles & Responsibilities

- 1. Organise at least two blood donation camps at SXC Jaipur in 2023-24.
- 2. In case of emergency, Suman Blood Bank will arrange a blood group/unit for the staff and students of the college.
- 3. Spreading Awareness about Blood Donation to the NSS Volunteers and Students of the College.
- 2. Fee & Honorarium: NIL
- 3. Terms of Renewal, Amendment, and Termination

This MOU shall remain in force for period of **one year** from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months' notice to the other Party in writing. If this agreement is terminated by either party, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the parties agree in writing to renew it. This MOU may be amended by the exchange of official letters between the two parties. Such amendments, once approved by both Parties, will become part of this MOU. Neither Party may assign this MOU or any right under this MOU without the prior written consent of the other Party. This MOU shall become effective upon the signature of the legal representatives from each party.

Visiting party will comply with the rules of the host institution.

#### NO AGENCY

Nothing in this MOU gives rise to a relationship of agency between the parties.

# O NO JOINT VENTURE, PARTNERSHIP OR EMPLOYMENT RELATIONSHIP

 Nothing in this MOU shall be relied upon to construe a joint venture, partnership or employment relationship between the Parties.

# NO TENANCY OR INTEREST IN PROPERTY

 Nothing in this MOU shall create or shall be construed to create any tenancy or to confer or be construed to confer upon one Party any interest in any, all or part of the grounds, building or premises of the other Party.

Any notice or other communication to any party hereto (whether required or permitted to be given under or in connection with this MOU) shall be in writing and shall (at the option of the party giving the notice) be sent by registered post to the address set out under its name below, or to such other address as is from time to time notified to the party giving the notice in compliance with the provisions of this clause IV:
