MEMORANDUM OF UNDERSTANDING

&

VINOBHA GYAN MANDIR - A NON- GOVERNMENTAL ORGANISATION

This Memorandum of Understanding is made on 2nd day of October 2023

BETWEEN St. Xavier's College, Jaipur having an address at Nevta-Mahapura Road, Nevta, Jaipur, Rajasthan – 302029 (hereinafter referred to as SXC Jaipur') AND Vinobha Gyan Mandir Jaipur' (hereinafter referred to as VGM Jaipur') and collectively referred to as 'the Parties')

WHEREAS:

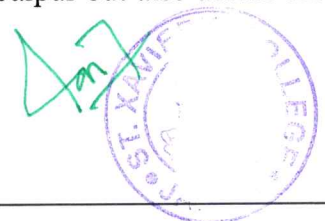
Vinobha Gyan Mandir, recognizing the value of cooperation, have agreed to enter into this Memorandum of Understanding ('MOU') regarding academic/non-academic collaboration. The purpose of this non-binding Memorandum of Understanding (MOU) is to make possible and to institute academic collaboration/ strategic partnership between 'SXC Jaipur', and 'VGM Jaipur', based upon the principles of mutual equality and the reciprocity of benefits.

Both Parties HEREBY AGREE:

I. Knowledge and Facilitation Partner

SXC Jaipur has requested VGM Jaipur, Non-Governmental organization to facilitate the promotion of Gandhian Values and principles.

VGM Jaipur, has agreed to be the facilitation Partner of SXC Jaipur. This MOU will promote various programs to promote Gandhian principles.

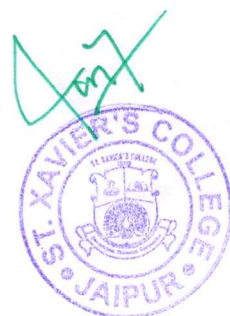

II. Roles & Responsibilities:

SXCJ

- Provide students for the enrolment in the Examination.
- Providing space for Exhibition.

- To, provide Gandhian literature to the students.
- To conduct online/offline examination.
- To organize Exhibitions for the promotion of Gandhian Values.
- To promote innovative ways to develop sensibilities among the students to spread Gandhian principles.
- To conduct composed pit Demonstration among the villagers
- To help form small rainwater Harvesting in villages under UBA.
- To help to establish E-Mitra.
- To work for social Harmony.

III. Fee and Honorarium

Honorarium, if any, will be decided based on mutual understanding of both the parties.


IV. TERMS OF RENEWAL, AMENDMENT, AND TERMINATION

This MOU shall remain in force for a period of **one year** from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months' notice to the other Party in writing. If either party terminates this agreement, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the parties agree in writing to renew it. This MOU may be amended by the exchange of official letters between the two parties. Such amendments, once approved by both Parties, will become part of this MOU. Neither Party may assign this MOU or any right under this MOU without the prior written consent of the other Party. This MOU shall become effective upon signature of the official representatives from each party

V. OTHER TERMS AND CONDITIONS

- **COMPLIANCE WITH LAWS**
 - Both parties will comply with all relevant laws in the jurisdiction in which it is **in situ** and all visiting scholars and faculty shall comply with all relevant laws in the jurisdiction of the host Party.
- **COMPLIANCE WITH COLLEGE RULES**
 - Visiting party will comply with the rules of the host institution.
- **NO AGENCY**
 - Nothing in this MOU gives rise to a relationship of agency between the parties.
- **NO PARTNERSHIP OR EMPLOYMENT RELATIONSHIP**

- Nothing in this MOU shall be relied upon to construe a joint venture, partnership or employment relationship between the Parties.
- **NO TENANCY OR INTEREST IN PROPERTY**
 - Nothing in this MOU shall create or shall be construed to create any tenancy or to confer or be construed to confer upon one Party any interest in any, all or part of the grounds, building or premises of the other Party.
- **NOTICES**
 - Any notice or other communication to any party hereto (whether required or permitted to be given under or in connection with this MOU) shall be in writing and shall (at the option of the party giving the notice) be sent by registered post to the address set out under its name below, or to such other address as is from time to time notified to the party giving the notice in compliance with the provisions of this clause IV:


