## **PLEASE NOTE THE FOLLOWING TERMS AND CONDITIONS:**

1. The Transport fee will be charged for the Complete Academic Session payable in advance either in 100% advance or in **Two Equal Installments** (By Post Dated Cheques). The full fee will be due and payable even if the transportation service is unutilized/ utilized partially during the year.
2. The charges will remain fixed irrespective of the number of working days in a month.
3. The fee calculation is determined by the actual distance between the college and the pickup point, plus an additional 5 Kms.
4. The final pick-up, drop-off points and seats will be allotted by the transporter. Any requests for changes will not be entertained. However, if a request for a change in pick-up/drop location is due to a change in address, an additional fee will be applicable.
5. The final pick-up and drop-off points shall be established by the transporter following a comprehensive route survey.
6. In regard to the Tavera, a minimum of 10 students must be present on the specified route, otherwise, the cost will be proportionally divided among the parents.
7. The Transportation Services will be suspended in case of non-payment of fees within 7 days of utilization of service.
8. All dues in regard to the transport fee for the Previous Academic session must be cleared in order to avail the transport facility for the New Academic Session. Failure to comply with this requirement may result in the denial of transportation services.
9. All students using the college transport must abide by the instructions given by the driver/conductor/transport authorities at all times.

**Mode of Payment:** Payment for transportation services may be made by means of **Demand Draft (D.D)** payable to "Mannat Skill Bus Service" payable at Jaipur/ by Cheque made payable to "Mannat Skill Bus Service"/ **through cash payment.** In case you are paying the fee through the driver, kindly inform by call/ message on the mentioned numbers.
