Anti-Ragging Compliance: Mandatory Online Affidavit Submission – Ragging is Strictly Prohibited (Academic Session 2026–27)

All First-Year Students (Session 2026–27) are hereby informed that, as per the directives of the University Grants Commission (UGC) and the Anti-Ragging Regulations, it is mandatory for every student to submit the Online Anti-Ragging Affidavit/Undertaking before the commencement of regular classes.

Important Instructions

1. Ragging is strictly prohibited within the college campus, hostels, transportation, and all places under the jurisdiction of St. Xavier's College Jaipur.
2. Any student found involved in ragging, directly or indirectly, shall be liable for strict disciplinary and legal action as per the UGC Anti-Ragging Regulations and the rules of the College. The punishment may include suspension, rustication, expulsion from the institution, filing of an FIR, or any other action deemed appropriate by the competent authority.
3. All First-Year students must visit the following official Anti-Ragging portal and complete the Online Anti-Ragging Affidavit:

4. All students must complete the Online Anti-Ragging Affidavit by **01 September 2026**.
